What If Your Health or Prescribed Medication Change?

We base our quotes on your current medical status at the time of taking out your policy. If your medical circumstances change before you travel, there is no increase in premium however it's a good idea to let us know, as long as you are still fit and well to travel. When your renewal is due we review your medical details again at which time there may be an impact on your renewal.
